



EORI: to help EU economic operators and customs officials implement the Economic Operators Registration and Identification number concept. The course is available in English, Bulgarian, Estonian, German, Hungarian, Lithuanian, Romanian, Slovak, and Macedonian (more to come). 45 minutes of information-rich training covering issues such as what EORI means for companies, who needs to apply and how.

SASP: to help European traders as well as customs officials to implement the legal concept of Single Authorisation for Simplified Customs Procedures. Four hours of training, cover issues such as context and key concepts, application and authorisation processes, operation and management of SASP. The course is available in English, Bulgarian, Estonian, Slovenian and Spanish (more to come).

DCP-EO: to help the chemical industry and other relevant businesses recognise the risk of illicit trade in drug precursors, and train staff in methods to avert the diversion of drug precursors for illicit use. Three hours of training cover issues such as the legal framework, EU guidance and best practice and address security and management aspects. It is currently available in English, French and Portuguese (more to come).



The courses available:

VAT: to help interested traders, the public and specifically tax officials in the EU acquire good basic knowledge on the EU Directive 2006/112/EC, known as the VAT Directive'. Six hours of training cover issues such as taxable persons, chargeable events and taxable amounts, right to deduct and final assessment. The course is available in English, German, Hungarian, Bulgarian and Spanish (more to come).

AEO: to help European companies learn about the European Authorised Economic Operator legislation and the necessary procedures to acquire AEO status. Nearly three hours of training, cover issues such as context, application procedure and criteria are available in English, French and German.
